

## **Ty Louis Campbell Foundation/Muddy Puddles Project**

### **Welly Walk Sweepstakes Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

#### **1. ELIGIBILITY**

The Welly Walk Sweepstakes (the "Sweepstakes") is open to legal residents of the forty-eight (48) contiguous United States and the District of Columbia who are at least eighteen (18) years old (19 in AI or NE) at the time of entry. Employees of Ty Louis Campbell Foundation, Entertainment One and other companies associated with the promotion of the Sweepstakes, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to federal, state, and local laws and regulations.

#### **2. AGREEMENT TO OFFICIAL RULES**

Participation in the Sweepstakes constitutes full and unconditional agreement to and acceptance of these Official Rules and decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

#### **3. SWEEPSTAKES PERIOD**

The Sweepstakes begins on September 1, 2017 at 12:00AM Eastern Time (ET) and ends on March 15, 2018 at 11:59PM ET ("Sweepstakes Period").

#### **4. HOW TO ENTER**

During the Sweepstakes Period, register for a Welly Walk at [muddypuddlesproject.org](http://muddypuddlesproject.org) by completing and submitting the registration form, including a complete legal name, valid home address, and email address (the "Participant") and name of organization you are authorized to represent for this Sweepstakes (the "Required Information"). Upon completion and submission of the registration form, participants who fundraise \$50 or more via donations to The Muddy Puddles Project through a "Welly Walk" Fundraiser are automatically entered with one (1) entry into the Sweepstakes. You may also enter without raising any donations by sending a 3x5 card with the Required Information to 1787 Route 6, Carmel, New York, 10512. All mail in entries must be postmarked by March 1, 2018 and received by March 7, 2018. Limit one entry per stamped outer envelope. P.O. Boxes are not permitted. You must provide all required information to be eligible to enter and win. All potential winners are subject to verification before any prize will be awarded. By registering, you agree that the Muddy Puddles Project may contact you via social media, including on Facebook, Instagram or Twitter by sending you a direct message, tagging you, posting to your social media page or naming you on the Muddy Puddles Project's social media pages. [Normal Internet access, phone, and usage charges imposed by your online or phone service may apply.] Limit: LIMIT ONE (1) ENTRY PER

**SWEEPSTAKES PER PERSON REGARDLESS OF METHOD OF ENTRY. ADDITIONAL ENTRIES WILL BE DISQUALIFIED.** Automated or bulk entries or entries submitted by third parties will be disqualified. Entries must be submitted by the Participant. No copies, facsimiles, or mechanical reproductions of the Entry Form will be accepted. Any attempt by any Participant to obtain more than the stated number of entries by using multiple and/or different identities, forms, registrations, email addresses, logins, or any other methods will void that Participant's entries, and that Participant may be disqualified at Sponsor's discretion. Multiple Participants are not permitted to share the same email address. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the Participant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder to the Sponsor [and/or the Administrator] or forfeit the prize. Entries specifying an invalid, non-working, or inactive email address will be disqualified and ineligible to win. You must complete all required information to be eligible to enter. Incomplete, illegible, corrupted, or untimely entries are void and will be disqualified. Sponsor and Sponsor's agents, affiliates, subsidiaries, representatives or service providers may use entrants' and/or referrals' personal information submitted with entry for purposes of prize fulfillment and/or for future marketing by Sponsor, such as to notify them of a product or promotion that Sponsor thinks may be of interest. Sponsor will not sell personal information submitted with entry to outside solicitors.

5. **PRIZES:** There will be five (5) potential winners.

**Sweepstakes One Prize:** One (1) winner will receive: 2 Peppa Pig DVDs, 2 Peppa Pig books, and a Peppa Pig plush toy. Estimated retail value \$57.95

**Sweepstakes Two Prize:** One (1) winner will receive: 2 Peppa Pig DVDs, 5 Peppa Pig books, a Peppa Pig plush toy, and a Peppa Pig game. Estimated retail value \$90.91.

**Sweepstakes Three Prize:** One (1) winner will receive: 1 Peppa Pig DVD library, 8 Peppa Pig books, 2 Peppa Pig toys, 1 Peppa Pig lunchbox, and 2 Peppa Pig games. Estimated retail value \$198.79.

**Sweepstakes Four Prize:** One (1) winner will receive: 1 Peppa Pig Prize Pack filled with books, DVDs, games, toys, puzzles, backpacks, and more. Estimated retail value \$300.00.

**Sweepstakes Five Prize:** One (1) winner will receive a meet and greet with the Peppa Pig costume character at a date and time in Sponsor's and Prize Provider's (defined in Rule 13 below) sole discretion. Before arrangements for this meet and greet can be confirmed, Sponsor will need written confirmation from an authorized representative of the Organization for the appearance of Peppa Pig. Organization shall also be responsible for securing signed Releases, which will be provided by Sponsor, for taking photographs and videos at the Organization's facility, if appropriate, and of those in attendance at the event. Attendance at the meet and greet should be by free invitation only and is limited to a number approved by Sponsor in its sole

discretion. If for whatever reason, or no reason, the Organization listed in the Participant's entry is unwilling or unable to accommodate the Peppa Pig costume character meet and greet, then Participant shall forfeit this prize and Sponsor shall have no further obligation to Participant. Sponsor shall, in its sole discretion, determine if this portion of the Sweepstakes can be awarded to another potential winner.

**Restrictions and Limitations:** You may enter more than one Sweepstakes. Sponsor's decisions as to the operation of the Sweepstakes and the selection of potential winners are final and binding in all matters related to the Sweepstakes. All prize details are subject to change and in the sole discretion of Prize Provider or representatives and in the event that Prize Provider is unable to provide a winner with his/her prize(s), the Prize Provider may elect, to provide winner(s) with the approximate value of such item in cash or award an alternate prize of comparable or greater value. All unclaimed prizes or unused portion of the prize shall be forfeited in its entirety. All prize(s) are awarded "AS IS" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). Sponsor and Prize Provider reserve right to substitute prizes of equal or greater value. No substitution or transfer of prizes permitted by winner. All prizes will be awarded (assuming sufficient number of eligible entries) subject to the rules herein. Sponsor reserves right to substitute prizes of equal or greater value or different value; no substitution or transfer of prizes permitted by winner. All prize details not specified in these Official Rules will be determined in each of Sponsor's and Prize Provider's respective sole and absolute discretion.

6. **DRAWING AND ODDS OF WINNING:** Between March 15, 2018 and April 1, 2018, Sponsor, Prize Provider or either of their representatives will conduct a random drawing (the "Drawing") from all eligible entries to determine Potential Winner(s). Entries are subject to verification and potential Winners are not declared final and shall not receive a prize until verified by Sponsor and/or Prize Provider. Sponsor's and/or Prize Provider's decisions are final and binding on all matters relating to this Sweepstakes. Odds of winning depend upon the total number of eligible entries received. Any attempts to exceed the limit of number of entries into the Sweepstakes by any method, including but not limited to, submitting multiple post cards or robotic entries, are prohibited and Sponsor and Prize Provider reserve the right, in their respective sole discretion, to disqualify all suspect entries. An individual may not enter on behalf of another individual or transfer his/her entry to another person. Sponsor's server and computer clock is the official timekeeping device and its decisions are final and binding. Results of the Sweepstakes are not official until Sponsor expressly announces the final results and verifies the winners.
7. **VERIFICATION OF WINNERS AND DELIVERY OF PRIZES:** Potential winner(s) will be notified by email or telephone within three (3) business days after verification by Sponsor or Prize Provider or either of their respective representative. Potential winner(s) are required to provide Sponsor and Prize Provider his/her name, residential address, telephone number, email address and valid photo ID (U.S. license, passport or similar proof of identity that is acceptable to Sponsor and/or Prize Provider in their sole discretion). An Entrant is not a winner of any prize unless and until the Entrant's eligibility has been verified and the Entrant has received notice from Sponsor that he/she has won the prize. Potential winner(s) may be required to sign an affidavit of eligibility

and liability release and, where permitted, a publicity release and a Form W9 concerning the prize. Additional paperwork, releases, background checks or screenings, to the extent allowed by law, may also be required before a prize can be awarded. If potential winner cannot be contacted within three (3) days, fails to return any and all requested documentation within ten (10) days, or is declared ineligible by Sponsor, in its sole discretion, he/she forfeits the prize in its entirety. Potential winners agree that Sponsor or Prize Provider may shorten these timelines for any reason. If potential winner forfeits a prize, Sponsor may, but is not required to, select one new potential winner.

## **8. GENERAL CONDITIONS**

Sponsor and/or Prize Provider reserve the right to disqualify any Participant if, in their sole discretion such Participant is not in alignment with Sponsor's or Prize Provider's values, has acted fraudulently in any way, prior, during or after the Sweepstakes, or if awarding a prize to the Winner could result in public disrepute, contempt, scandal or ridicule or could reflect unfavorably on Sponsor or Prize Provider. Prize Provider will not award a prize to any Winner who has engaged in any abusive behavior during the Sweepstakes Period. Fraudulent, abusive and any behavior in the realm of fraudulent or abusive are determined solely by the Sponsor or Prize Provider's and is not up to interpretation by any other party. Additionally, in such cases, if the Prize Provider already delivered a prize, they reserve the right to require the winner to return the prize. Sponsor and/or Prize Provider reserve the right, in their sole discretion, to prohibit any person or organization from becoming or remaining an entrant for any reason, including without limitation: (i) any attempt by an entrant to undermine the legitimate operation of the Sweepstakes by cheating, deception, or any other unfair practices; (ii) any Entrant violation of the Official Rules; or (iii) any Entrant acting in a disruptive manner, or with intent to annoy, abuse, threaten or harass any other person or organization. Without limiting the foregoing, the use of automated software or computer programs to register or to enter the Sweepstakes is prohibited and any individual who uses or attempts to use such methods to register or to enter will be disqualified. Sponsor and/or Prize Provider reserves the right, at its sole discretion, to modify, cancel, terminate or suspend this Sweepstakes should any virus, bug, technical failures, unauthorized human intervention or other causes beyond Sponsor's control corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes. If the Sweepstakes is terminated before the designated end date, Sponsor and Prize Provider will (if possible) select the winner based on eligible, non-suspect results received as of the date of the event giving rise to the termination, but PRIZE PROVIDER SHALL NOT BE OBLIGATED TO AWARD ANY PRIZE THAT RELATES TO OR ARISES OUT OF CHEATING, IMPROPER OR MISTAKEN PRIZE NOTIFICATION, OPERATION, OR FUNCTION OF THIS SWEEPSTAKES. CAUTION. ANY ATTEMPT BY ANY ENTRANT TO DELIBERATELY DAMAGE ANY WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THIS SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAWS. All Entrants acknowledge and agree that normal Internet access, phone and usage charges imposed by their online, phone or similar providers may apply.

## **9. RELEASE AND LIMITATIONS OF LIABILITY**

Participants expressly agree to release and hold harmless Sponsor and Prize Provider and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies and prize suppliers and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from any and all liability for any claim cause of action, loss, harm, damages, costs or expenses, including without limitation property damages, personal injury or death arising out of participation in the Sweepstakes or receipt, acceptance, possession, use or misuse of any prize awarded as part of this Sweepstakes, and claims based on publicity rights, defamation or invasion of privacy, merchandise delivery and/or travelling to or from any prize related activity. Entrants acknowledge and agree that the Released Parties are not responsible or liable in any way for: (i) late, lost, delayed, damaged, incomplete, illegible, unintelligible, misdirected or otherwise undeliverable donations or other communications; (ii) telephone, electronic, hardware or software program, network, Internet or computer malfunctions, failures, or difficulties of any kind, including without limitation any damage to any computer system resulting from participation in, or accessing or downloading information in connection with, this Sweepstakes; (iii) any condition caused by events beyond the control of the Sponsor or Prize Provider that may cause the Sweepstakes or any results in the Sweepstakes to be disrupted or corrupted; (iv) any printing, human, typographical or other errors or ambiguities in (or involving) any materials associated with the Sweepstakes; (v) any and all losses, damages, rights, claims and action of any kind in connection with or resulting from participation in the Sweepstakes; (vi) acceptance, possession, or use of any prize; (vii) claims based on publicity rights, defamation, or invasion of privacy relating to participation in the Sweepstakes; (viii) for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's email account to receive email messages or insufficient space on entrant's computer; and (ix) any alleged violation by Entrants of any law, regulation, or right held by a third party. By accepting the prize, winner agrees to release Released Parties and their directors, employees, officers and agents, including without limitation, its advertising and promotion agencies, from any and all liability, loss or damages arising from or in connection with the awarding, receipt and/or use or misuse of prize or participation in any prize-related activity.

#### **10. GOVERNING LAW AND DISPUTES**

This Sweepstakes is offered only in the contiguous 48 United States and District of Columbia and all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, Participant's rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of State of New York without giving effect to any choice of law or conflict of law rules. By entering, participants consent to the jurisdiction and venue of the federal, state and/or local courts in New York. Except where prohibited, Participants agree that: (1) any and all

disputes, claims and causes of action arising out of or connected with this Sweepstakes or other prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Southern District of New York or the appropriate New York State Court located in New York County, New York; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, and in no event will Entrant be entitled to receive attorneys' fees or other legal costs; and (3) under no circumstances will Entrants be permitted to obtain awards for, and Entrants hereby waive all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of New York, without giving effect to any choice of law or conflict of law rules (whether of the State of New York or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of New York.
